**AN ORDINANCE PERTAINING TO WATER RATES**

*BE IT ORDAINED BY THE OTTER LAKE WATER COMMISSION, ADGPTV, AS FOLLOWS:*

**SECTION 1:**

IMPOSITION OF RATES

Current Water Rates charged by the Commission to its customers shall henceforth have an annual 3% increase on its wholesale member municipality rates and its retail rates after the first 1,000 gallons used for the next five years. Wholesale customers other than member municipalities rates will remain to be member rates plus 5%. The annual rate increases shall go into effect on March 1<sup>st</sup> of each calendar year, beginning March 1<sup>st</sup>, 2022, ending and to be reevaluated after a term of five years. Current rates are as follows:

A. Wholesale, member municipalities:

\$5.09 per thousand gallons, effective December 1, 2018

B. Wholesale customers other than member municipalities:

\$5.34 per thousand gallons, effective December 1, 2018

C. Retail Customers:

1. For the first 1,000 gallons or any portion thereof in a monthly billing period:

5/8 inch meter - \$16.99 per month effective December 1, 2018

1 inch meter - \$22.49 per month effective December 1, 2018

1.5 inch meter -	\$30.74 per month effective December 1, 2018
2 inch meter -	\$33.49 per month effective December 1, 2018
3 inch meter -	\$42.29 per month effective December 1, 2018
4 inch meter -	\$70.00 per month effective March 1, 2022
6 inch meter -	\$80.00 per month effective March 1, 2022
8 inch meter -	\$90.00 per month effective March 1, 2022
10 inch meter -	\$100.00 per month effective March 1, 2022

2. For use in excess of 1,000 gallons in a monthly billing period:  
\$7.24 per 1,000 gallons, effective December 1, 2018
  
3. For fire lines: \$5.00 per month per inch of exterior diameter of the line.

**SECTION 2: FULL FORCE AND EFFECT REPEAL**

This ordinance shall be in full force and effect following its passage, approval and publication as provided by law and shall be implemented effective NOVEMBER 9, 2021. This ordinance supersedes all previous water rates ordinances of the Commission, including but not limited to “An Ordinance entitled 2017-05 “An Ordinance Pertaining to Water Rates”, approved the 9th day of May 2017. The Clerk shall publish this Ordinance in pamphlet form.

**SECTION 3:** This Ordinance is effective immediately. The clerk shall publish this ordinance in pamphlet form and mail a copy of this ordinance to all member municipalities within 5 days of its passage and approval.
